Mission Statement

The mission of Jamestown Tourism (JT) promotes, supports, and develops tourism growth in Jamestown, ND and the surrounding areas.

The Purpose

The Jamestown Tourism Grant Advisory Board is interested in funding projects that enhance the impact of the tourism industry in our city and county. Especially projects that generate economic impact in Jamestown.

Eligible Projects:

Unique Exhibits/Programs: Unique exhibits and/or educational programs at museums, historical locations, and attractions that would be of interest to visitors. The sponsoring organization must demonstrate that the program and marketing plan are designed to reach outside the local constituency.

Events & Event Enhancements: New or growing events can apply for support, for up to three years. Events can request dollars for new features or equipment adding to the experience for years to come. Items must fill a gap in the current event structure/program.



Capital Construction/Deferred Maintenance/Feasibility Study: Capital costs associated with the acquisition, restoration, or enhancement of existing historic buildings and sites or the construction or expansion of new and existing buildings or sites or the development of a study in regard to tourism. Projects must show an enhancement to tourism experiences and opportunities.

Eligible Recipients:

Any agency whose work influences the businesses of Jamestown and meets the mission of Tourism. Applicants must be legally incorporated or non-profit organizations. No individual may be awarded a grant.

Project Requirements:

- Only completed applications will be considered and should include the required information as outlined on the Application Form.
- 2. The project receiving JT Grant Funds must be located within Stutsman County.
- JT Grant Funds may not be used for any project designed to give personal or political gain to any organization or individual.

- 4. JT Grant Funds will NOT be awarded to a project that is completed.
- Applicants will assist with obtaining counts for JT to measure grant dollar's influence on economic impact.
- 6. Recognition commensurate with the award amount is required.
- 7. Applicants will be required to make a brief presentation to the JT to explain their need and answer questions or concerns.

How to Apply:

The Jamestown Tourism Grant Advisory Board shall review applications at their monthly board meetings (the 4th Monday). Submit applications by the second Friday of the month for review at that month's board meeting.

Jamestown Tourism Disclaimer:

JT reserves the right to approve or reject grant requests and to ask organizations for further clarification. The Jamestown Tourism Board will make all decisions regarding funds. Applicants are not guaranteed funding, the board may decide to award partial amounts if any at all.

The Grant Board reserves the right to consider special grant requests. Applicants should be aware that JT is funded by tax dollars and is subject to public record. All grant applications and required paperwork will become public record. JT does not provide insurance coverage for any project.
